By signing this form, you acknowledge the following:

- Foxtone will attend the property nominated below and install/replace the required number of smoke alarms in the property to meet the 2022 Queensland Smoke Alarm Legislation.
- The pricing structure outlined below provides an indicative quote only. Additional smoke alarms may be required in a property with a unique layout. If on attendance at the property, the technician uncovers that additional alarms are required for the smoke alarm system to comply to 2022 legislation, you authorise the installation of the additional alarms during that attendance and agree to pay the additional costs of those alarms.
- Foxtone will notify you by email following our attendance if additional alarms were installed.

- You are required to select either an PAA, MATElect or PSA smoke alarm. If you do not nominate a brand, Foxtone will install MATElect branded smoke alarms and charge you accordingly.
- Upgrade to 2022 compliance will be scheduled at the next available time slot as determined by Foxtone.
